# Statement on participation in Sustainability platforms and ratings

Dear Sir or Madam,

The Zollner Group is often asked to participate, register or be active on various CR/CSR/Sustainability platforms. The goal of these requests is always the same: Our customers desire an automated performance analysis that identifies the key ESG risks in their supply chain and enables them to better understand their suppliers' organization in order to recognize potential threats to environmental, social and economic performance.

With this in mind, Zollner has decided to use only the following platforms, where we can measure, report and share our sustainability performance with our partners.

# NQC SUPPLIERASSURANCE – <u>https://supplierassurance.com/</u>

The SUPPLIERASSURANCE platform is provided by NQC Ltd., an independent company. This platform allows third-party organizations to answer an **SAQ 5.0 questionnaire** and share it with their customers. The SAQ 5.0 is a **Sustainability Assessment Questionnaire** that covers the topics of Company Management, Human Rights and Working Conditions, Health and Safety, Business Ethics, Environment, Responsible Supply Chain Management and Responsible Sourcing of Raw Materials.

The questionnaire was developed by the members of the Drive Sustainability initiative - The Automotive Partnership to verify compliance with sustainability regulations by the suppliers of the automotive industry. An SAQ goes through the following 3-step process on the SUPPLIERASSURANCE platform before it is completed:

## 1. Responding

When completing the SAQ 5.0, suppliers must answer a series of questions within the topic areas above. When answering the questions, evidence must be uploaded to support the answers. The evidence must meet the evidence criteria applicable to the corresponding questions and substantiate the selected answers.

## 2. Validating

The SUPPLIERASSURANCE team will review the evidence to ensure that the documents meet the acceptable evidence criteria. If evidence does not meet the criteria or does not cover the chosen answers, a so-called "gap" will be raised.

## 3. Results

Once the SAQ has been reviewed, the supplier is notified of the results (including ratings), gaps and suggestions for improvement. The supplier then has the opportunity to update its SAQ answers to address gaps or demonstrate improvement in its sustainability performance - the SAQ process restarts and any improvements are recorded in the platform.

RBA-Online is an online sustainability data management system designed to help RBA members (Responsible Business Alliance) and their suppliers manage and share sustainability data, including from audits and self-assessment questionnaires that assess risk at the corporate, facility and supplier levels. Key functions of RBA-Online include:

- Online completion of the **RBA self-assessment questionnaire (SAQ)**, including online analysis by a company's customers (as authorized by the supplier)
- Entry of data from the RBA Validated Assessment Process (VAP)
- Effective corrective action management and non-compliances verification process
- Secure sharing of common supplier social responsibility data with customers

RBA SAQ and VAP produce in-depth evaluations of the social, ethical, occupational health and safety and environmental performance of suppliers as measured against the audit criteria (AC). The audit criteria are based on the RBA Code of Conduct and verify conformance with it.

#### Carbon Disclosure Project (CDP) - https://www.cdp.net/en

CDP is an independent reporting and assessment platform on environmental issues and the largest of its kind in the world. There are three possible topic areas (Climate Change, Water or Forests). The focus is on emission reduction or climate protection. The questions are dynamic (i.e. based on the answers), have different weightings and are structured in "levels". The CDP questionnaire thus comprises approx. 70 -140 pages and is adapted to progress and fundamentally revised every 3 years. The rating covers a scale from A (good) to F (participation refused). The result does not only assess the emission reduction, but rather reflects the awareness, integration and maturity of the topic area in the company. The assessment result is public, but details must be released. The assessment is valid for one year and must be updated the following year.
