Dear Business Partner!

As a result of the changes in the Hungarian legislation, the EKAER notification obligation has changed significantly.

From January 1, 2021 **exclusively** land transports **of products subject to reporting obligation** are to be reported to the tax office if they fall under the following directions of goods traffic:

- purchasing of goods from another EU Member State;
- supplies of goods to another EU Member State;
- the import and export of the products with a different objective;
- first supply of goods subject to taxation in domestic trade, to other than end users.

The range of products subject to EKAER reporting obligation is the same as the range of products previously described as risky products.

The list of products subject to reporting obligation (risky products) can be found in the Regulation of the Ministry for National Economy 51/2014. (XII. 31.) NGM under the following link: <https://ekaer.nav.gov.hu/cikkek/risky-products>

**To summarize, the EKAER notification obligation will be omitted for most products.** Economic operators registered in Hungary are now exempt from the reporting obligation with regard to goods deemed non-risky under the previous regulation. **From 2021 the obligation to request an EKAER number may only arise with regard to goods subject to reporting obligation (deemed risky under the previous regulation).**

One important difference, that the reporting obligation is applicable not only for goods transported by a vehicle subject to road toll payment, thus vehicles exceeding 3,5 tons of maximum permissible gross weight, but it may be applicable for road transportation with any type of vehicle.

It is still outside of the scope of EKAER regulation, thus it doesn't need to be reported, when goods subject to reporting obligation are dispatched by the same consignor (supplier) to the same consignee (e.g. ZOLLNER Kft.) with the same vehicle as one transport and the total gross weight does not exceed 500 kgs or the total value without VAT does not exceed HUF 1 million. In addition, postal items continue to be exempt.

The related sanctions have also changed. A default penalty of 40% can only be imposed if the taxpayer fails to comply with EKAER's reporting obligation or declares an incorrect quantity or value. In the latter case, 40% shall apply to the quantity and value of the goods of unconfirmed origin. Other errors (misspellings, incorrect license plates, failure to close the event, etc.) in the case of legal persons are punishable by a fine of up to HUF 500,000.

**We ask you to continue to send us the delivery information for all deliveries without exception, regardless of the delivery terms and the EKAER status of the delivery, in order to ensure the smooth reception of your vehicles.**

We have prepared a form (.xls) for the shipping advice, please send it completely and correctly to your Zollner contact person by e-mail by 12:00 noon on the working day before each scheduled delivery.

This shipping advice is much simpler than the previous EKAER data sheet, it contains only general transport-related information. (The EKAER data sheet used so far is no longer requested.)
